#### SISTRi: EXTENSION AND START PAYING CONTRIBUTION YEAR 2012.

The decree called "Milleproroghe" took steps to change the terms of entry into force of SISTRi and to indicate the start of the system SISTRi formally on 1 July 2012, while in fact up to that date the previous system of forms, registers and penalty system. However there are still three implementing decrees that allow the full application of SISTRi. It remains pending their enactment trusting that happen soon otherwise we will have to wait yet another extension.

There remains however the obligation to pay the annual fee to ensure coverage of costs resulting from the establishment and operation of the new control system of traceability of waste. This obligation is with art. 4 of the Ministerial Decree December 17, 2009. The deadline for the payment refers to calendar year 2012 is set at 30 April 2012 and is regulated by the DM July 9, 2010.

The admission fee SISTRi can be made at:

The Notice must contain:

a) the number of the receipt of postal order, the deposit amount, the number of practice to which the payment relates.

b) or the number of "Reference Code" Operation (CRO) of the bank, the deposit amount, the number of practice to which the payment relates.
